

# **EDITORIAL** It's Time to Repeal the Unfair Estate Tax

There are many important issues of concern on the Federal level, but to an independent service station dealer or repair facility operator none may be as important as the proposal to repeal the National Estate Tax.

As we conclude our 2017 area breakfast meetings, this is indeed a very emotional issue for association members.

As WMDA members increasingly purchase their stations and facilities, it is more important than ever to repeal this burden.

One association member told me that he has built his business from the bottom up and his goal is to be able to pass it on to his son, but he knows that his son could never pay the estate tax.

Following decades of hard work and growth, that member believes that his business is "worth" \$32M. Like many small business owners, his business may be worth a certain amount, but that in no way means he has either that much money or anything close to that much money.

To protect his business and to ensure that his son will be able to inherit the business, he has taken out an insurance policy to pay the inheritance tax. His annual insurance policy premium is \$62,000! Talk about an incentive not to grow your business!

The estate tax, in my opinion, is un-American. It challenges the ethics of hard work and success. It needs to be repealed.



President Trump supports repeal of the Estate Tax. WMDA, with SSDA-AT, has worked for decades to repeal the law. With a Republican Congress, the time is right under the tax reform effort to repeal the Estate Tax.

WMDA/CAR/SSDA-AT is a member of the Family Business Estate Tax Coalition (FBETC). This Coalition is dedicated to the full and permanent repeal of the estate tax. In working with Rep. Kevin Brady and the Coalition we were able to pass the Death Tax Repeal Act of 2015 (HR 1105) on a 240-179 vote.

With the 115<sup>th</sup> Congress, the opportunity for Estate Tax Repeal is greater than ever. HR 63 and S 205 amends the Internal Revenue Code to: (1) repeal the estate and generation-skipping transfer taxes, and (2) make permanent the maximum 35% gift tax rate and the lifetime gift tax exemption. The bill provides for an inflation adjustment to such exemption amount.

WMDA/CAR/SSDA-AT supports the Death Tax Repeal Act of 2017 for the following reasons:

#### REPEALING THE DEATH TAX WOULD SPUR JOB CREATION AND GROW THE ECONOMY.

Many studies have quantified the job losses caused by the death tax. Last year the Tax Foundation and Heritage Foundation both found that the US could create over 100,000 jobs by repealing the death tax. A 2012 study by the House Joint Economic

> Committee found that the death tax has destroyed over \$1.1 trillion of capital in the US economy – loss of small business capital means fewer jobs and lower wages. Lawrence Summers, former Secretary of the Treasury under President Clinton; Alicia Munell, member of President Clinton's Council of Economic Advisors; Joseph Stiglitz, a Nobel laureate for economics; and Douglas Holtz-Eakin, former CBO Director have all published work on the death

tax's stifling effect on job growth and the economy as a whole.

# THE DEATH TAX CONTRIBUTES A VERY SMALL PORTION OF FEDERAL REVENUES.

The death tax currently accounts for less than half of one percent of federal revenue. There is a good argument that not collecting the death tax would create more economic growth and lead to an increase in federal revenue from other taxes. A 2014 Tax Foundation analysis found repeal of the death tax would increase federal revenues by \$3.3 billion per year using a more realistic, "dynamic" economic analysis.

#### A SUPER-MAJORITY OF LIKELY VOTERS SUPPORT ELIMINATING THE DEATH TAX.

Poll after poll has indicated that a super-majority of likely voters support repealing the death tax. Typically, twothirds of likely voters support full and permanent repeal of the death tax. People instinctively feel that the death tax is not fair.

#### THE DEATH TAX IS UNFAIR.

It makes no sense to require grieving families to pay a confiscatory tax on their loved one's nest egg. Often

this tax is paid by selling family assets like farms and businesses. Other times, employees of the family business must be laid off and payrolls slashed. For many family-owned businesses to keep operating after the death of the owner, they must plan for the estate tax. Planning costs associated with the estate tax are a drain on business resources, taking money away from the day to day operations and business investment. These additional costs make it more difficult for the business owner to expand and create new jobs. Protecting family business from the estate tax is important in order to keep these businesses operating for future generations.

#### YOU CAN MAKE A DIFFERENCE!

In early 2018 dealers and repairs facility operators nationwide will come to Washington, DC, to meet with their legislator to support the effort to repeal the Estate Tax.

If you own your own facility, or if you plan to buy, you have a vested interested in this issue. If you want to your business to stay in your family, come and tell your story. Remember, nobody can tell your story as well as you can.

This is our best opportunity to repeal the Estate Tax. With your help, it will happen!

# LEGISLATIVE UPDATE Federal Update

#### ESTATE TAX

Recently, WMDA/CAR attended a Family Business coalition meeting to discuss the Death Tax Repeal Act of 2017 and other tax reform initiatives. It appears repealing the estate tax will be part of comprehensive tax reform and part of a larger package.



Congress is expected to begin focusing most of its time on tax reform. WMDA/CAR spoke with Congresswoman Kristi Noem (R-SD) who is the lead sponsor of the Death Tax Repeal Act of 2017 and she believes that the prospects for passage are strong and there is interest in Congress to move quickly on this issue. Her bill currently has 59 co-sponsors.

WMDA/CAR will continue efforts on Capitol Hill to gain support for repealing the estate tax once and for all.

#### SBLC TAX AND REGULATIONS UPDATE

Last month, the Small Business Legislative Council (SBLC) (we are in the leadership), testified at the House Small Business Committee hearing entitled "Cafeteria Plans: A Menu of Non-Options for Small Business Owners." The purpose of the hearings was to spotlight how owners of pass-through entities are NOT able to participate in these advantageous employee benefit plans.

Currently the law discriminates against sole proprietors, partners, and any Sub-S stockholder with more than 2% of stock, as well as that person's





family members, and a member of an LLC that has chosen to be treated for tax purposes as a partnership, by not allowing them to participate in cafeteria plans. Cafeteria plans allow employees to select among a choice of employee benefits including flexible spending accounts (FSAs), dependent care, contributions to HSAs, group term life insurance, vision and dental insurance, and supplemental health insurance programs (like those offered by Aflac).

In the testimony, we requested a halt to this blatant discrimination which also hurts the employees of these businesses since it is a hard sell to convince owners to adopt a plan that will generate some administrative expense and burden when they are excluded from the benefits of the plan. Additionally, we asked for an increase to the absurdly low dollar limits on FSAs and the dependent care benefit (currently \$2,500 and 5,000 respectively). Finally, we asked for long term care insurance to be included as a permissible benefit.

Later in the month, WMDA/CAR participated in an SBLC legislative summit to discuss the current prospects of healthcare reform, tax reform, the debt ceiling, transportation funding, and other pending issues Congress plans to address in 2017. We remain an outspoken leader and contributor to SBLC and often join them in lobbying efforts.

WMDA/CAR joined more than 150 other organizations and associations on letters to Senate Homeland Security and Government Affairs Chair James Lankford and House Small Business Committee Chair Steve Chabot in support of the Small Business Regulatory Flexibility Improvements Act. The bill would amend the Regulatory Flexibility Act to help better ensure that small business interests and impacts are considered in the rulemaking process.

#### LIFO UPDATE

In April, WMDA/CAR attended a Save LIFO coalition meeting. As tax reform discussions begin to heat up, so do the possibilities



of repealing LIFO. With the border adjustability proposal facing backlash, there is a possibility it could be off the table, with all other areas of revenue back on the table, including reforming or eliminating the LIFO system.

It is expected that repealing LIFO could bring the federal government \$70-105 billion on a one time hit. We will remain active in the coalition and in tax reform discussions in Washington.

#### TRANSPORTATION FUNDING

In April, we attended a Highway Users board meeting, where Roy Littlefield serves as Treasurer. In the meeting, we discussed



the options for funding if Trump were to put forth a robust infrastructure plan.

If he wants to propose a \$1 trillion bill, all funding options are back on the table including many aimed at the tire industry. We will continue to be active players in transportation funding discussions.

There will be much disagreement on some major issues such as motor fuel taxes – state governors are almost united in their support of a major motor fuel tax increase. The U.S. Chamber of Commerce and the powerful road builders lobby all support a major increase (and indexing the tax to inflation so that it goes up in future years without having to go through Congress).

(1) Five-Year+ Federal Aid Highway Bill	Support
(2) Motor Fuel Tax Increase	Oppose
(3) Privatization of Highways	Oppose
(4) Weight-Distance Tax	Oppose
(5) Vehicle Miles Driven Tax	Oppose
(6) FET on Tread Rubber	Oppose
(7) FET on Passenger Tires	Oppose
(8) Increase FET on Truck Tires	Oppose





# KIRK'S KORNER Legislative Update

#### GOVERNOR SIGNS LOTTERY BILL INTO LAW

The background on this will explain why we decided to have a bill introduced. Four years ago the lottery and gaming commission decided they were going to put traditional lottery on line. We found out that approval was not needed from legislators and Governor Martin O'Malley was not going to stop this from happening.

Our agents heard all the hype about how an online lottery was not going to hurt our lottery agents and, in fact, it would help by creating more interest. One look at brick and mortar stores that have succumbed to pressure from online retailers was proof enough. Agents were being fed a line of baloney from lottery and gaming. We were able to do an end-around and stop the move to online thanks to a senator that is small business friendly and looked at the move by the head of lottery as a disaster for our agents and to small business in general.

Governor Hogan was elected and appointed a new director of the lottery and gaming commission, Gordon Medenica. In 2016, a 10-year contract was put out to bid for lottery services. Within the contract was a requirement that the winning company have the capability to develop online lottery sales.

WMDA had a meeting with Mr. Medenica and was told he had no plans of putting the lottery online. He also thought he had to prepare for any possibility since it was a 10-year contract. Gordon Medenica has always been straight forward and honest with WMDA and so has the assistant director of the lottery, John

WMDA and their partner trade associations felt we had to do our due diligence. Therefore, we had a bill introduced that would take the decision away from the Maryland Lottery and put it in the hands of the legislators and the governor. Senator Conway and Delegate Bromwell were the sponsors of the bill and we thank them for their sponsorship.

Governor Hogan signed the bill on May 4, 2017 – SB438 and HB813. The bill says the State Lottery and Gaming Control Agency will not establish any system or program that allows a person to purchase a state lottery ticket through an electronic devise that connects to the internet, such as a personal computer or mobile device.

# 2017 CarMD<sup>®</sup> Vehicle Health Index<sup>™</sup>: Just What the Doctor Ordered

We live in an information age. To some, it probably seems like information overload because we are constantly bombarded with statistics, studies and surveys. To others, those statistics, studies and surveys are roadmaps to success because they use the information to make better decisions. The recent 2017 CarMD Vehicle Health Index provides a wealth of data that automotive repair facilities can use to make sure that the right services are being offered and most importantly, at the right price.

On the surface, the Index provided some good news as the industry saw a 2.7% increase in the average repair costs after two years of no growth. The overall 4.7% increase in labor and 1.4% increase in parts costs were also welcome news in a tough market. The CarMD Vehicle Health Index also breaks it out by region and for whatever reason, the Mid-Atlantic is considered the south (see South Region Chart on page 13) where there was a 2.9% increase in the total average repair costs for 2016. While that is slightly better than the national average, it still trails the Midwest where the increase was 5.7% for 2016.

Besides measuring the most common repairs, the Index also looked at the age of vehicles that reported a check engine light problem. According to CarMD, the average age of a vehicle with a check engine light was 11.9 years old. Considering the average age of vehicles in the U.S. is 11.6 years based on IHS Markit data, it makes sense that the 2005 model year was the most likely at 10.7%, 2006 was next at 10% and 2004 was the third most likely model year to experience a check engine light at 9.25%. IHS Markit started tracking the average age of vehicles in 2002 and according to their data, the oldest vehicles on the road are growing the fastest. In fact, IHS research estimates that vehicles 16 years and older will grow 30% from 62 million vehicles in 2016 to 81 million vehicles in 2021. Again, this is good news for the automotive repair, service and maintenance industry.

CarMD reported that the 5 most common check engine light problems nationally are faulty oxygen sensor (8%), catalytic converter (6.75%), ignition coil and spark plugs (6.23%), loose fuel cap (4.16%), and mass air flow sensor (3.84%). Repairs that experienced the biggest drop in frequency were replace thermostat at number 9 (down from number 5), replace the evaporative emissions canister vent solenoid at number 14 (down from number 13), replace engine coolant temperature sensor at number 21 (down from number 18) and replace the intake manifold gasket(s) at number 23 (down from number 17). Replace the evaporative emissions vent control valve (number 22) and replace the crankshaft position sensor (number 25) were new to the list. The Top 10 Most Common Check Engine Vehicle Repairs in the Southern U.S. in 2016 are shown on page 13.

Perhaps the most valuable piece of information in the CarMD Vehicle Health Index is the total average repair cost for parts and labor. The chart shows the top 10 most common check engine light repairs for the southern U.S. in 2016 as well as the average cost. While independent automotive repair shops want (and need) to be competitive, it's money lost when prices are too cheap and repeat business lost when prices are too high. This data is extremely valuable when assessing the costs for the most common repairs since many consumers will have access to this information. To illustrate this, I did a simple Google search on "replace oxygen sensor" and quickly discovered that the \$259.46 average cost reported by CarMD was consistent with other estimates from YourMechanic and Edmunds. In an age where most consumers are going to use the Internet to see if they are getting a good deal, the importance of quoting prices that are in line with the various industry websites cannot be understated.

WMDA/CAR exists so independent automotive repair shops in the Mid-Atlantic have access to resources like the CarMD Vehicle Health Index. We are constantly looking for information that our members can use to improve the profitability of their businesses and provide better value to their customers. The entire CarMD Vehicle Health Index can be accessed and downloaded from the WMDA website (www.wmda.net) after clicking on the CAR tab located on the main menu. WMDA/CAR members are encouraged to download the entire report and use the information to make sure their prices are competitive when quoting customers on common repairs that are easily searchable on the Internet. This information is out there for anyone to see and companies who use it will definitely have an advantage over those who do not.


